Good instruction on accident investigation directed toward municipal employees.
- 0020 Accident Reporting (4:40)**
- 0030 Back Care – Public Agency and Construction Employees (13:00)**
Address safe lifting techniques and safe methods for shoveling, breaking pavement and many other tasks directly related to public agency and construction employees.

Provides detailed operation and maintenance procedures for backhoe and loader operators.

The program explains Due Process, Ad Judicatory Decisions, Discoverable Testimony, and the need to follow an entity's existing land-use regulations. Group home and adult business examples are used to show the consequences to public officials of "targeting" certain projects. Public officials are also shown how to document their decision-making and the considerations for disqualifying themselves from a zoning case. (2 Tapes)
